Before using any tank-mixture, consult and comply with the recommendations of the partner products. Each product should be added separately to the bulk of the water in the spray tank and thoroughly mixed before adding the next chemical.

Always use constant agitation of the sprayer tank during mixing, transportation and application. Spray immediately.

## **#PGR TANK-MIXTURES**

FLEXURE + AZOXYSTAR may be applied, before GS32, in mixture with one of the following: TRINESTAR (or Moddus) 0.2L + chlormequat 1.25L (winter wheat); TRINESTAR (or Moddus) 0.1L + chlormequat 1.25L (winter barley – light soils or malting crops); TRINESTAR (or Moddus) 0.2L + chlormequat 1.25L (winter barley – other soils and feed crops). Do not use FLEXURE + AZOXYSTAR + TRINESTAR (or Moddus) + chlormequat on spring barley.

Check all the manufacturers' latest guidance before using any of the above mixtures.
